MODE OF MEETING

The 26th AGM of the Company will be conducted on a virtual basis by way of live streaming and online remote voting via Remote Participation and Voting facilities via Securities Services e-Portal ("SS e-Portal") at https://sshsb.net.my/.

Kindly be advised that the Broadcast Venue, which is the main venue of the 26th AGM, is strictly for the purpose of complying with Section 327(2) of the Companies Act 2016 and Clause 82 of the Company's Constitution, which require the Chairman to be present at the main venue of the 26th AGM.

No shareholders, proxies and/or corporate representatives from the public should be physically present or admitted at the Broadcast Venue on the day of the 26th AGM.

Shareholders/proxies/corporate representatives are able to participate, speak (including posing questions to the Board via real-time submission of typed texts) and vote (collectively, "participate") remotely at the 26th AGM via eLive and eVoting facilities provided by SS e-Portal.

Please note that SS e-Portal is best viewed on the latest versions of Chrome, Firefox, Edge and Safari. The quality of connection to the live broadcast is dependent on the bandwidth and stability of the internet connection of the location and the device used by the participants.

GENERAL MEETING RECORD OF DEPOSITORS ("ROD")

Only members whose names appear in the ROD as at 14 May 2024 shall be entitled to participate and vote at the 26th AGM or appoint proxy(ies) to participate and/or vote on his/her stead.

POLL VOTING

The voting at the 26th AGM will be conducted by way of poll in accordance with Paragraph 8.29A of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad. The Company has appointed SS E Solutions Sdn. Bhd. as the Poll Administrator to conduct the poll voting via SS e-Portal and Commercial Quest Sdn. Bhd. as the Independent Scrutineer to verify the poll results. The voting module has been made accessible to all shareholders/proxies/corporate representatives to submit your votes from the commencement of the 26th AGM and shall close upon the closure of the voting session to be announced by the Chairman of the 26th AGM. Upon completion of the voting session for the 26th AGM, the Independent Scrutineer will verify and announce the poll results, followed by the Chairman's declaration of whether the resolutions are duly passed.

RESULTS OF THE VOTING

Results of the voting on the resolutions proposed at the 26th AGM will be announced at the 26th AGM and subsequently, via an announcement made by the Company through Bursa Malaysia Securities Berhad at https://www.bursamalaysia.com.

RECORDING OR PHOTOGRAPHY

Strictly NO unauthorised recording or photography of the proceedings of the 26th AGM is allowed.

DOOR GIFT

There will be no distribution of door gifts for participation in the 26th AGM.

PROCEDURES FOR REMOTE PARTICIPATION AND VOTING VIA SECURITIES SERVICES E-PORTAL

BEFORE THE 26TH AGM

FIRST, sign up for a user account at Securities Services e-Portal

ALL USERS MUST SIGN UP AS USERS BY THURSDAY, 16 MAY 2024

- Step 1: Visit https://sshsb.net.my/
- Step 2: Sign up for a user account.
- Step 3: Wait for our notification email that will be sent within one (1) working day.
- Step 4: Verify your user account within seven (7) days of the notification email and log in.
- This is a ONE-TIME registration. If you already have a user account, you need not register again.
- Your email address is your User ID.

SECOND, once you have successfully registered as a User of Securities Services e-Portal, log in to https://sshsb.net.my/ with your registered email and password

All documents that are not in English or Bahasa Malaysia must be accompanied by a certified translation in English in 1 file. The original evidence of authority and translation thereof, if required, have to be submitted to SS E Solutions Sdn. Bhd. at Level 7, Menara Milenium, Jalan Damanlela, Pusat Bandar Damansara, Damansara Heights, 50490 Kuala Lumpur, Wilayah Persekutuan, Malaysia for verification before the registration closing date and time above.

Step 2: Submit your registration.

- A copy of your e-Registration for remote participation can be accessed via **My Records** (refer to the left navigation panel).
- You need to register for remote participation for all the CDS account(s) you have or represent as an individual shareholder or corporate or authorised representative.
- As the 26th AGM will be conducted on a virtual basis and only the Chairman will be present at the broadcast venue, we highly encourage all shareholders to remotely participate and vote at the 26th AGM, failing which, please appoint the Chairman of the 26th AGM as proxy or your own proxy(ies) to represent you.

 - Step 2: Enter your CDS account number or the body corporate's CDS account number and corresponding number of securities. Then enter the information of your proxy(ies) and the securities to be represented by your proxy(ies).
 - You may appoint the Chairman of the 26th AGM as your proxy where you are not able to participate remotely.
 - Step 3: Proceed to indicate how your votes are to be cast against each resolution.
 - Step 4: Review and confirm your e-Proxy Form details before submission.
- A copy of your submitted e-Proxy Form can be accessed via My Records (refer to the left navigation panel).
- You need to submit your e-Proxy Form for every CDS account(s) you have or represent.

PROXIES

All appointed proxies need not register for remote participation under (B) above, but if they are not registered Users of the e-Portal, they will need to register as Users of the e-Portal by Thursday, 16 May 2024. PLEASE NOTIFY YOUR PROXY(IES) ACCORDINGLY. Upon processing the proxy forms, we will grant the proxy access to remote participation at the 26th AGM to which he/she is appointed instead of the shareholder, provided the proxy must be a registered user of the e-Portal, failing which, the proxy will not be able to participate at the 26th AGM.

- Your votes cast will apply throughout <u>all</u> the CDS accounts you represent as an individual shareholder, corporate/authorised representative, and proxy. Where you are attending as a proxy, and the shareholder who appointed you has indicated how the votes will be cast, we will take the shareholder's indicated votes in the proxy form.
- The access to eVoting will close when the Chairman announces the closing of all voting at the 26th AGM.
