MODE OF MEETING

In view of the COVID-19 outbreak and as part of the best health practices, the 23rd AGM of the Company will be conducted on a fully virtual basis online via **Securities Services e-Portal** at <https://www.sshsb.net.my/>.

This is in line with the latest Guidance Note on the Conduct of General Meetings for Listed Issuers issued by the Securities Commission Malaysia on 5 March 2021.

Kindly be advised that the Broadcast Venue is strictly for the purpose of complying with Section 327(2) of the Companies Act 2016, where the Chairman shall be present at the main venue of the AGM.

No shareholders/proxies from the public should be physically present or admitted at the Broadcast Venue on the day of the 23rd AGM.

Registered Shareholders/Proxies/Corporate Representatives/Attorneys are able to participate, speak (including posing questions to the Board via real-time submission of typed texts), and vote (collectively, “participate”) remotely at the 23rd AGM via eLive and eVoting facilities provided by Securities Services e-Portal.

Please note that the e-Portal is best viewed on the latest versions of Chrome, Firefox, Edge, and Safari.

GENERAL MEETING RECORD OF DEPOSITORS (“ROD”)

Only a depositor whose name appears in the ROD as of 10 May 2021 shall be entitled to participate in the 23rd AGM or appoint proxies to participate and/or vote on his/her behalf.

POLL VOTING

The voting at the 23rd AGM will be conducted by poll in accordance with Paragraph 8.29A of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad. The Company has appointed SS E Solutions Sdn. Bhd. as Poll Administrator to conduct the poll by way of electronic voting and Commercial Quest Sdn. Bhd. as Scrutineers to verify the poll results. The voting module has been made accessible to all shareholders and proxies to submit your votes from the commencement of the meeting and shall close upon the closure of the voting session to be announced by the Chairman of the meeting. Upon completing the voting session for the meeting, the Scrutineers will verify and announce the poll results followed by the Chairman’s declaration of whether the resolutions are duly passed.

RESULTS OF THE VOTING

Results of the voting on the resolutions proposed at the 23rd AGM will be announced at the AGM and subsequently, via an announcement made by the Company through Bursa Malaysia at <https://www.bursamalaysia.com>

PROCEDURES TO REMOTE PARTICIPATION AND VOTING VIA SSeP

BEFORE THE MEETING

FIRST, sign up for a user account at **Securities Services e-Portal**

ALL USERS MUST SIGN UP AS USER BY 11 MAY 2021

- Step 1 Visit <https://www.sshsb.net.my/login.aspx>
Step 2 Sign up for a user account
Step 3 Wait for our notification email that will be sent within one (1) working day
Step 4 Verify your user account within seven (7) days of the notification email and log in

- This is a **ONE-TIME** registration. If you already have a user account, you need not register again.
- Your email address is your User ID.

Step 2 Submit your registration.

- You need to register for remote participation for **all the CDS account(s)** you have or represent as an individual shareholder or corporate, or authorised representative.
- As the meeting will be conducted on a fully virtual basis and only the Chairman will be present at the broadcast venue, we highly encourage all shareholders to remotely participate and vote at the meeting, failing which, please appoint the Chairman of the meeting as proxy or your own proxy(ies) to represent you.

Step 1 Check if you are submitting the proxy form as –

Step 2 Enter your CDS account number or the body corporate's CDS account number and corresponding number of securities. Then enter the information of your proxy(ies) and the securities to be represented by your proxy(ies).

You may appoint the Chairman of the meeting as your proxy where you are not able to participate remotely.

Step 3 Proceed to indicate how your votes are to be casted against each resolution.

Step 4 Review and confirm your proxy form details before submission.

- A copy of your submitted e-Proxy Form can be accessed via **My Records** (refer to the left navigation panel).
- You need to submit your e-Proxy Form for **every CDS account(s)** you have or represent.

PROXIES

All appointed proxies need not register for remote participation under (B) above, but if they are not registered Users of the e-Portal, they will need to register as Users of the e-Portal by **11 May 2021 (in view that 13 and 14 May 2021 are public holidays in Malaysia, and 15 and 16 May 2021 falls on the weekend)**. PLEASE NOTIFY YOUR PROXY(IES) ACCORDINGLY. Upon processing the proxy forms, we will grant the proxy access to remote participation at the meeting to which he/she is appointed for instead of the shareholder, provided the proxy must be a registered user of the e-Portal, failing which, the proxy will not be able to participate at the meeting as the meeting will be conducted on a fully virtual basis.
